## General Usher Duties

- Head Ushers are responsible for taking attendance during both services.
- Position yourself just inside the door INSIDE the worship center.
- Assist people with finding places to sit as the worship center starts to fill up. (Encourage regulars to move up a row in the middle sections and to move closer to the wall in the outer sections).
- Provide one bulletin per family and to whomever asks for one.
- Tidy worship center (extra bulletins, connect cards, etc.) between services.
- In the winter, please arrive by 8:15 to help shovel/de-ice walkways. Otherwise be ready by 8:45 am. You are free to go after attendance is taken in the second service.
- Please read through the bulletin each week to be able to answer questions and help direct people.

You are required to find your own replacement if you cannot make it during your scheduled time.
