GRAND RAPIDS EVANGELICAL FREE CHURCH Quarterly Business Meeting July 18, 2023

Quintin Legler opened the meeting with prayer.

- 1. Previous meeting minutes Minutes from the 4/28/23 meeting were distributed and reviewed. Jason Green made a motion to accept the minutes as written; it was seconded by Lisa Mrnak, and the motion passed.
- 2. Elder Report Larry Curtiss reported on the following activities of the Elders over the last quarter:
 - Spent a great deal of time helping set the schedule and coverage for Sunday Pathfinders, Jr. and Sr. High programming, Children's Sunday services and the Nursery.
 - A retreat in October for the Elders is being planned.
 - Focusing on core values and organization structuring
 - Monthly prayer meetings
- 3. Executive Board Reports
 - A. Chairman Overview Quintin Legler reported on the following:
 - The church needs a person to assist with IT needs, hopefully a volunteer.
 - Peterson Accounting has been filling in with accounting services while Bill Grothe, the accounting assistant, has been out. Bill returned on 7/19/23.
 - The Board, with Michelle's assistance, has been looking for an operational software, including a new website or app, to help with many different functions.
 - The balance of the CIF investment fund (from the donor) has a balance of \$152,703.05. This is being held until a decision is made of how to use it.
 - A decision by the Board and Elders has been made to budget for the Associate Pastor position in 2024, as the finances have been growing. The search team will be assembled and voted on at the next quarterly business meeting.
 - B. Financial Secretary Lisa Mrnak reviewed the giving for the 2nd quarter, April June 2023. General giving = \$115,497.24, designations = \$14,385.16, miscellaneous = \$12,103.26, for a total of \$180,826.66.
 - C. Treasurer Lorraine Curtiss reported on the financial status of the church as of 6/30/23 as follows:
 2023 YTD Income = \$281,638.48; 2023 YTD expenses = \$229,741.34 vs, YTD budgeted expenses = \$221,825.99.

- D. Facilities Report Scott Schwake reported on the following facility items that have been completed or on the to-do list:
 - The furnace and air conditioning unit were replaced.
 - Playground equipment has arrived. Doug Hanson is working on site preparation and soon the equipment can be installed.
 - There currently are no CO detectors so installation of them is in progress.
 - Sound bafflers for the worship center are in progress.
 - Barn doors are sagging and need repair.
 - The security light in the parking lot was repaired and now working.
 - Leaky faucets in the women's bathroom ae being fixed.
 - More security cameras are needed and will be ordered.
 - No smoke detectors are currently installed; this project is being bid.
 - The alarm system keypads have been fixed and moved to a better location. Staff will be trained on how to disarm them.
 - Yard cleanup has been contracted out.
 - Reverse osmosis water tanks have arrived and will soon be installed.
 - Landscaping team completed the new flower bed near the east entrance.
 - Shawn O'Donnell is now doing the lawnmowing. Shawn also has been cleaning out the storage closet off the worship center.
 - Jim Azure cut down 3 dead trees.
 - The youth room now has a lock on the door.
 - It was suggested to have sand and salt more handy for the winter months.
 - It was suggested to have cameras installed on the stage in the worship center.
- 4. Sr. Pastor Report Pastor Micah Labovitch reported on the following:
 - He and the financial team have been working on a financial procedures manual.
 - Marilyn Isaac stepped down as Financial Secretary; Lisa Mrnak has been filling in.

- 2 Executive Board positions will be ending in December: Lorraine Curtiss will be stepping down as Treasurer, and Sandy Harling's term will be expiring.
- He and the Elders have been reading and discussing the "Lead" book.
- The membership class is being revamped.
- The interview process for new members has been revamped.
- The mission, vision, and strategy was revamped in 2021, but the values (to define who we are) have not been visited since 2014 and is in process.
- He has been reading Evangelical Convictions, an EFCA book about history and values of the conference.
- Bi-annual performance reviews with the staff have been completed.
- Many new people/new Christians are coming to our church he is prayerfully working on discipleship plans. He is looking for people to lead discipling classes, to lead people.

5. Ministry Reports –

- A. Children's Ministry and Preschool Sarah Schrapp reported that many people have stepped up to continue teaching during the summer. August is a break for teachers with no classes during the Sunday services. Bible Boot Camp was held in June and was exciting and good. Discussions are in progress regarding how the fall classes/ministries will look. Laura Boyd retired as teaching assistant from the Preschool. Recruitment for her replacement is in progress.
- B. Jr. High Rachel Staudahar reported that District Blitz was well attended and was awesome. Allies have 8 weeks of summer events for youth grades 6-12 which our church will participate with. She helped with a reading through a book of the Bible together, and was encouraged to see that students are discipling other students! For the fall Jr. and Sr. high will both meet on Sunday nights. It is being planned for kids to get involved in the community doing service projects.
- C. Sr. High Kevin Geisler reported that Sr. High students have been involved in a lot of the same activities as the Jr. High. They are working on putting down deep roots with the students and equipping them to know Jesus. A lot of time has been spent praying for each other and others.
- D. Young Adults Joe Forsline reported that Tuesday nights are gathering times for this group either Ultimate frisbee, bowling or volleyball. He stated that the leaders of this group are getting older and entering new phases in their lives, so the leadership is navigating how to keep this ministry going. A men's bible study is being considered.
- E. Men's Ministry Tim Hasbargen reported that a men's bible study is held on Monday nights. The intent is for the application of bible verses to everyday life and what is currently happening in mens' lives. Beans,

- Bags and Brats event is planned for next month. 2 more men are needed for the core team.
- F. Women's Ministry Michelle Schwake reported that 1 social event is occurring during each of the summer months. A fall Bible study(s) is being planned. October 6 is the annual Thrive conference in Rochester. There are 14 Titus Tables groups meeting currently.
- G. Legacy Builders Kathy Miller reported that this ministry is currently partnering with the Better Together group. The Bordners will be attending the national conference in the fall, and a picnic at Tioga is being planned for September.
- H. Bereavement Team Diane Legler reported that the team has assisted with several funerals and is fine-tuning their processes. The most recent funeral was for Sheila Dorholt. Donations to this fund would be so helpful so that families in need would not need to pay for food and supplies.
- I. Connecting and Hospitality Jim Azure reported that 2 potlucks have been held so far and both have gone well. An ice fishing event is again being planned for the winter. Two August events are being planned the Gunn Park outdoor service and a baptism service at Tioga Beach.
- J. Midweek Meals Karla King reported that the first year of this ministry went great, and that the 2nd year starting in the fall is being planned. Everyone, even those without young children, is invited to attend the meals on Wednesday evenings. Several teams rotate through the season and have been wonderful to work with.
- K. Missions Duane Mrnak reported that this committee is currently looking for more members. 11% of the weekly giving is budgeted for missions. Frank Gangi will be the new chairman beginning with the next meeting on July 30. They are in the process of revising their policies and procedures.
- L. Safety Team Quintin reported that this committee is not doing much at this time. Many are interested in being part of the team, but no one is interested in leading. Policies and procedures need to be developed per the church's liability insurance. Unofficially this team is handling the nursery security.
- M. Welcome Team Michelle Schwake reported that this team is a well-oiled machine. August 13 is Serve Sunday and if anyone else would like to join the team they can sign up then. A new position being sought is a Children's Ministry Greeter.
- N. Worship Team Alicia Alleman reported that Kim Hake has stepped up to be one of the worship leaders, and that there are 2 new members to the team. They meet weekly and begin with a devotional that is focused on worship. A bereavement request form is being developed for use in assisting with funerals music, etc. The team is working on the music for the Gunn Park service next month. Also, a strategic plan is in process. Alicia reminded everyone that the musical instruments remain on the stage and to be careful when events occur in the worship center, and to pull the curtain to protect the equipment. Currently

there are 41 members of the team, and there is always a need for additional sound and computer technicians.

- 6. Old Business there was no old business presented.
- 7. New Business -
 - A. Voting on new members

 The Elders brought forward a recommendation for 2 individuals to be added to the membership: Clayton Linder and Emily Linder. Ballots were distributed, collected and tallied. Both individuals were unanimously voted in.
- 8. The meeting was adjourned. Pastor Micah closed in prayer.

Lead Pastor 3rd Quarter Report October 17th 2023

Colossians 3:23: "Whatever you do, work heartily, as for the Lord and not for men, knowing that from the Lord you will receive the inheritance as your reward. You are serving the Lord Christ."

It is easy in the demands of life for all of us to miss the incredible blessings of ministry that God has bestowed on us at GREFC. Baptisms, Picnics, the Gunn Park service, Serve Sunday, Leader Training Week, pre-marital counseling, visioning meetings, the launch of all ministries and programs this fall, prayer nights, staff and leadership meetings, the elder retreat, studying and preaching through the Gospel of Matthew, preparing and building up others to preach and teach in the Fall Disciple series, preparing for Advent, preparing for next years fiscal budget, praying together, partnering with the other churches of Grand Rapids in the Pastor's Prayer Fellowship, etc. And the list can go on from there! There have been so many moments, so many things to look at and celebrate the Lord's movement at GREFC. So many things that I am so humbled to have been a part of as I look at all the servant-hearted leaders that surround me. And it causes me to be even more excited about what the Lord God desires to do here in the people of GREFC!

First, over the next few months, we will pause our Matthew series and embark in two new sermon series: one focusing on the discipleship of the believer and one focusing on the Advent season. This Sunday, Dan Carlson will be kicking off our "disciple series" The DNA of a Disciple. This series actually came out of the congregational response during the visioning process I have been walking through with the Elders these past several months. As the responses came in from the congregation, there was a continuous theme: the things that define a disciple of Jesus Christ ought to be the things that help define *us* as a local church. So 5 of our church leaders- Dan Carlson, Tim Hasbargen, Myself, Chris Brown, and Quintin Legler- will lead us in a study of 5 of those key elements that build up disciples (and disciplemakers) in Jesus Christ! Then we will be moving into our Advent series "Christmas Songs," in which will study songs in the scriptures *outside* of the book of Psalms that point to the anticipation of the coming of Jesus Christ.

Second, the elders, ministry leaders, staff, and executive leaders will continue to press forward with many "defining" elements into who we are as a covenant Christian Community at GREFC. Finalizing our values, changing and finalizing the 2024 budget, creating strategic plans and programs for the next year (and following), and more. Please continue to pray for Christ's unity, indwelling, and guidance within the elders, executive board, staff, and ministry leaders ahead!

Finally, we will begin our search for the next Associate Pastor at Grand Rapids Evangelical Free Church. The Associate Pastor snapshot is on the back of this report. They will have oversight over all the ministry leaders/ directors of GREFC, including ministry staff and volunteer directors. They may serve as a temporary ministry director, until one is placed for ministries as well. The role may include opportunities to preach, teach, counsel, and lead as desired. They will be a "Shepherd of Shepherds" that will be able to prayerfully guide, advise, and support existing leadership volunteers and teams. Please pray for us as we prayerfully seek the Lord's guidance, wisdom, and unity to find the person that God desires to bring to GREFC to serve in this role!

Christ is building His Church. And He has called us to participate in the process. May we continue to be unified and guided by His Word, His Spirit, and His Presence together as one family. Thank you GREFC Family for your prayers, encouragement, support, and servant-hearted worship.
